Several states mandate continuing education on specific subjects:

AIDS/HIV: FL, KY (initial licensure; license renewal); WA (initial licensure)

INFECTIOUS DISEASE CONTROL: AL, AZ, CA, CT, KY, MD, NM, NY, ND, OH, RI, WV, (WI-DHs only)

CHILD ABUSE IDENTIFICATION AND REPORTING: IA - (Dentists only); NY

CPR (or other Life Support e.g. BLS) CERTIFICATION: ID (DH only); AZ, GA, HI, IA, KY, MD, MN, NV, ND, NC, NM, NY, OK, PA, PR, SC, SD, TN, UT, VA, WY, (WI-DHs only)

DOMESTIC VIOLENCE: CT, FL

ORAL HEALTH EFFECTS OF TOBACCO: NY (dentist need only take a 2 hour course one time in career.)

CE Credit hours for dentists treating underserved: CT-10, FL-5, ID-5, MN-20, NJ-3, NV-6, WV-5

ETHICS CE required: IN, NY (1 time 3 hr. course only)

- (1) Dental Lab Technicians-8 hours of C.E. every 2 years.
- (2) Dentists get max. 20 hrs. of C.E., Hygienist & Assistants 10 hrs. every 2 years for providing volunteer care.
- (3) Only Advanced Dental Assistants must fulfill continuing education requirements.
- (4) Dental Hygienists and Dental Assistants who operate x-ray machines must take twelve hours C.E. in radiology.
- (5) CE waived partially or entirely for active duty military. Check with the dental board for details.
- (6) Dentists-4 hours CE within two years of initial licensure on medical consequences of an act of terrorism.
- (7) AZ Affiliated Practice DHs must have CPR and 12 of the required credits in specified subjects.
